CLEVELAND, O., June 5 (Special)—Battle over seats at the Republican National convention which opens here next week attracted the attention of the entire nation as Chairman Henry P. Fletcher and his colleagues settled down to business immediately upon their arrival here Tuesday morning from Washington.

From present indications this will be the largest Republican convention since Theodore Roosevelt was nominated in Chicago, and the most bitter since the same Roosevelt bolted the regular and organized the Bull Moose party.

With the local arrangements committee, Chairman Fletcher and his aide spent the first day receiving and passing in contests which as usual came piling in from Louisiana, Mississippi, South Carolina and the District of Columbia.
