Fugitive From Alabama Prison Wins Freedom In Court

PAPERS FOUND FAULTY BY HIS 2 ATTORNEYS

James Thomas Noble, 28, 921 E., is a free man again. He was set free Monday by Circuit Judge James E. Chenot who granted a writ of habeas corpus obtained by Noble's attorneys, Albert Williams and Harry Barcoff.

Noble was arrested last October by officers as a draft evader. It was discovered that he was wanted as a fugitive from the Kilby Prison in Alabama.

Granted Hearing

Noble was granted a hearing in Lansing, but the extradition papers were signed by Gov. Kelly. The lawyers then obtained a writ of habeas corpus and Noble won his freedom when it was shown that the extradition papers from Alabama were faulty.

Noble was arrested five years ago in Alabama on a larceny charge and sentenced to two years and three months after his conviction. He escaped three months later. He had been living here three years when he was arrested.

He is married and the father of one child. He was working as a window cleaner.
